#### Step 1: Receiving an invitation

• To initiate the registration process you will receive an invitation by e-mail. The sender is Ahlstrom-Munksjö Smartbuy (....@eusmtp.ariba.com / ....@ansmtp.ariba.com). You might have to check your junk folder but you can also choose to whitelist this sender in advance, before receiving the invitation.

### Step 2: Signing in / Creating an account

• Once redirected, you will have the option to sign in to your existing SAP Business network (Ariba network) account or to create a new account. Please choose the option applicable for you.

• You will now see Ahlstrom's registration questionnaire. Please fulfill the questionnaire and provide bank, tax and general details. You will be asked to add attachments relevant to your bank and tax details. You will also be asked to review, sign and upload Ahlstrom's Supplier Code of Conduct.
