Ahlstrom-Munksjö's Policy is to implement and achieve the Principles of Sustainable Forestry including: promoting sustainable forestry, employing responsible practices, regenerating the forest and maintaining productive capacity, protecting and maintaining long- term forest and soil productivity, protecting water resources, protecting special sites and biological diversity, complying with all applicable legal and regulatory requirements, and continually improving its practices.

## Ahlstrom-Munksjö's EU Timber Regulation Compliance Statement

The EU Timber Regulation aims to reduce illegal logging by ensuring that no illegal timber or timber products can be sold in the EU. It was created as part of the EU's Forest Law Enforcement, Governance and Trade (FLEGT) Action Plan in 2003.

The Action Plan sets out measures to:

- Prevent the import of illegal timber into the EU
- Improve the supply of legal timber
- Increase demand for timber from responsibly managed forests

The EU Timber Regulation came into force on March 3, 2013. It prohibits operators in Europe from placing illegally harvested timber and products derived from illegal timber on the EU market. 'Legal' timber is defined as timber from forests, which have been managed and harvested in compliance with the laws of the country and/or subnational region where the timber originated. There are two primary components with ensuring the legality of timber:

- Forest management - is the forest where the timber was harvested being managed legally?
- Supply chain control - what controls are in place to ensure that the timber really is from a legal source and has not been mixed with other timber?

Ahlstrom-Munksjö recognizes illegal logging as a serious and global problem. We are committed to the responsible management of forests and to use of legally and sustainably harvested wood from all sources. We take responsibility to trace our fiber sources back to the forest and obtain appropriate third-party certification or compliance documentation from our suppliers to adhere to our Sustainability Policy and Commitment.
