## **Acquisition in brief**

- Ahlstrom will acquire 100 percent of the shares in Munktell Filter AB, a Swedish-based filtration and separation company
- Through the transaction, Ahlstrom will become a global leader in life science and laboratory filtration
- The transaction will support Ahlstrom's strategic aim to focus on high performance materials that provide attractive growth opportunities
- Munktell operates production and conversion sites in Sweden and Germany, has a sales office and warehouse in the U.S., as well as a joint venture conversion site in France
- Transaction value approximately EUR 20 million

### **Transaction rationale**

- Ahlstrom has chosen to focus on advanced technologies and products that enable
  - protecting people
  - purifying air and liquids
  - providing structure and surface to customers' products
- The acquisition allows Ahlstrom to grow in advanced filtration such as life science and laboratory applications
- There is a clear fit between the companies both geographically and in terms of products
  - Improves competitiveness through combining Munktell's strong position in Europe with Ahlstrom's solid presence in North America
  - Enables expansion of product portfolio and provides access to membrane technology

### **Munktell Group in brief**



- Swedish filtration and separation company with a long track record and a well-established position in Europe
- Headquartered in Falun, Sweden, production and conversion sites in Sweden and Germany, a sales office and warehouse in the U.S., as well as a joint venture conversion site in France
- Net sales in 2011 approximately EUR 15 million, operating profit margin roughly 15% in 2011. Employs some 100 people
- Produces filtration materials for life science and laboratory applications, process filter media for industrial purposes, as well as air filtration media
- End-use examples include new born screening, laboratory media filtration, filter materials for pollution control, as well as testing materials used by medical, sugar and beverage industries.
